100 Mile House and District Minor Hockey Association	The boundaries of the 100 Mile House MHA shall be north from the point where the Cariboo Regional District's southern boundary intersects the 122 degrees meridian, east along the Cariboo Regional District's southern boundary to a point directly south of where Highway 97 intersects the 52 degrees N. Lat, north to 52 degrees N lat, eastward to 121 degrees w Long, north to the height of land between the Canim Lake and Horsefly River/Moffat Creek drainage areas to the head of Spanish Creek and the Cariboo Regional District boundary. The boundary continues south along the Cariboo Regional District boundary to Lac des Roches and continues south to 51 degrees 15'N. Lat., west to 122 degrees W. Long and north to the Cariboo Regional District boundary.
Abbotsford Female Hockey Association	City of Abbotsford and Sumas Mountain unorganized territory. Transitional Provision: For the 07-08 season, Female players whose parents are residents within the draw zone and who were last registered with Abbotsford MHA shall be permitted a onetime option to register with Abbotsford Female HA without having to process an Application for Player Movement under the "No Female Team" section. Abbotsford Female IHA shall supply the PCAHA Executive Director with a list of all players taking this option.

Aldergrove Minor Hockey Association	The Municipality of Langley and a portion of the Municipality of Matsqui, as follows: Northern Boundaries - Fraser River, #1 Freeway (280th street to 276th Street). Southern Boundaries - 0 Avenue, Eastern Boundaries - 276th Street (#1 Freeway to the Fraser River), 280th Street (0 Avenue north to the #1 Freeway), Western Boundaries - 232nd Street
Arbutus Club Minor Hockey Association	Section II - Draw Zones for Private Clubs Only - area of the City of Vancouver and the University Endowment Lands west of a line following Argyle Street (North Arm of Fraser River to 41 st Avenue), 41st Avenue (Argyle Street to Fraser Street), Fraser Street (41 st Avenue to Kingsway), Kingsway (Fraser Street to Broadway), Broadway (Kingsway to Burrard Street), and Burrard Street (Broadway to Burrard Inlet)
Boundary Minor Hockey Association	Starting at the point on the American border where the western boundary of the Kootenay-Boundary meet, following that boundary between the Kootenay-Boundary and Okanagan-Similkameen Regional Districts north to a point directly west of where Savnier Creek joints Wilkinson Creek and continuing east to Trapping Creek, northeast following Trapping Creek to the height of land at the head water and directly northeast following that boundary to the height of land to the east of Christian Valley road, south to Gable Mountain, turning southeast following the height of land west of the Granby River Crossing Highway No. 3 at Eolland continuing south to the American border, the American border will serve as the southern border.

Burnaby Winter Club	Section II - Draw Zones for Private Clubs Only - Municipality of Burnaby
Burns Lake Minor Hockey Association	From the East end of Babine Lake following Henrietta Creek, South to Taltapin Lake then further South to Island Lake then due south to the next MHA boundary. Following the South shore of Babine Lake going West to approximately 125 degrees – 50 minutes longitude then Southwest to Ailport Creek where it crosses Highway 16, then further Southwest to 54 degrees - 40 minutes latitude then due South to the next MHA Boundary.

Campbell River Minor Hockey Association	The area bounded to the south - along the Oyster River with a portion to the southwest extending into Strathcona Park; to the north - just north of Sayward including Kelsey Bay; to the northeast/east - including Blind Channel, Phillips Arm, Stuart Island, Read Island (Surge Narrows), Quadra Island and Cortes Island
Canal Flats Minor Hockey Association	North - Along Dutch Creek to where the two tributaries meet, than up the second one, east to the head waters of the Columbia River, than straight over the height of land to where the White River and the Elk Creek meet, down the White River to the East White fork. South - Along the Skookumchuck Creek to the Kootenay River, than a straight line over the height of land to the head waters of Quinn Creek, down the water shed to where it meets with the Bull River. East - Up the Bull River to its head waters, over the height of land, down the East White River to where it meets with the White River. West - From the head waters of Dutch Creek, down the height of the Purcells' to the head waters of Skookumchuck Creek.
Cariboo District MHA	The boundaries of the Cariboo MHA shall be those of the Fraser - Fort George. Cariboo and central Coast Regional Districts and that portion of the Thompson-Nicola Regional District south of 100 Mile House, encompassed by an area bounded by the southeast corner of the Cariboo Regional District (near Lac des Roches) south to 51 degrees, 15' N.lat, west to 122 degrees W. Long and north to the Cariboo Regional District boundary.
Castlegar Minor Hockey Association	Starting from the mouth of China Creek and following the boundary between the Central Kootenay and Kootenay-Boundary Regional Districts west and then north to Johnston Creek, east down Johnston Creek to the Arrow Lake, east in straight line to the northern boundary of the Village of Winlaw, south of Highway No. 6 to the Slocan junction, across Kootenay River to the height of land on the east side of Kootenay River, south to the summit of Highway No. 3 between Castlegar and Salmo, following Champion Creek to the Columbia River, across the river, up China Creek to the Nancy Greene junction on Highway No. 3 and north of Highway No. 3 to the Paulson Bridge.
Chase Minor Hockey Association	East - From Chase east along the Trans Canada Hwy 7 km to the mouth of the Big Shuswap and South east from there including Turtle Valley Road and Skimikin Road to Fleming Lake. Also the North side of Big Shuswap Lake to Anglemont the Squilax Anglemont Hwy. West - West of Chase to Rocky Point Bluff on the Trans Canada Hwy. All of Martin Prairie Road and Duck Range Road up to Hwy 97A. On the North Side of the Thompson River the boundary would be directly across from Rocky Point Bluff along the Kami-shuswap Road. Pinantan Lake Road to the McNulty Road, including all of Warren Road. South - South of Chase along the Chase Creek-Falkland Road to Pillar Lake. North - North of Chase to 5k past the mouth of Adams Lake. Including Little Shuswap Road and Holding Road.
Chetwynd and District Minor Hockey Association	South - to Tumbler Ridge boundary; North - From Carbon Creek east past Mount McAllister to the south west corner of the District of Hudson's Hope along southern boundary and up the eastern boundary of Hudson's Hope District to the Peace River then along the south side of the Peace River to a point 5 km east of Attachie; West - Along Rocky Mountains from Tumbler Ridge boundary up to Highway 97 at the summit (Azouzetta) along Highway 97 north to the point where the highway swings east, then north to Carbon Creek; East - From point 5 km east of Attachie, south-east to the Pine River at Favels Creek, down along the Pine River (and including the area on the east side of the Pine River up to the top of the hill along Highway 97) and down the Murray River to the
Chilliwack Minor Hockey Association	City and Municipality of Chilliwack and unorganized territory south of the Fraser River east to Cheam View. Clearwater and District Minor Hockey Association	South - Badger Lake Road including on or north of Badger Lake Road. All players living south of Badger Lake Road will be within Kamloops Minor Hockey boundary. North – Extends as far as the North Thompson River Bridge on Highway 6 north. Everything north of the bridge goes to Valemount. Also part of the boundary is the southern line which is created by the Prince George - Mt Robson Electoral District from its intersection with the Cariboo North Electoral District and the Kamloops - North Thompson Electoral District. West - The line drawn between the Cariboo North Electoral District and the Kamloops - North Thompson Electoral District to the head of Spanish Creek, proceeding south to include Wentwork Lake. East - Where the Kamloops - North Thompson Electoral District boundary touches on the Columbia Reach. Proceeding southward along the Kamloops - North Thompson Electoral boundary south to Badger Lake Road. The Kamloops - North Thompson Electoral boundary from Badger Lake Road north is Clearwater Minor Hockey.
Cloverdale Minor Hockey Association	Northern Boundaries - Fraser River, Southern Boundaries - 32nd Avenue (196th Street to 168th Street) and 40th Avenue (168th Street to 152nd Street), Western Boundaries - 152nd Street (40th Avenue to 88th Avenue) and 160th Street (99th Avenue to Fraser River), Eastern Boundaries - 196th Street (Fraser River to 32nd Avenue).
Comox Valley Minor Hockey Association	From the Oyster River Bridge north of Courtenay to Rosewall Creek on the south Boundary of the Regional District of Comox-Strathcona.
Coquitlam Minor Hockey Association	The Municipality of Coquitlam.
Cowichan Valley Minor Hockey Association	The Municipality of North Cowichan, the City of Duncan, the Town of Ladysmith, Thetis Island Northern Boundary Grid Line No. 16, starting east of Sansum Narrows going due west of Sansum Narrows to Electoral District E. North of Stratford Crossing to Takala Road. Players living on Salt Spring Island will be considered as part of Cowichan Valley Minor Hockey Association
Cranbrook Minor Hockey Association	North - From the top of White Boar Mountain to the top of Mount Evans, south of St. Mary Lake and down the St. Mary River to where it drains into the Kootenay River, then north of Fort Steele to the Wild Horse River, down the stream to the Kootenay River and then down the Kootenay River to where the Bull River enters the Kootenay River. South - 49th parallel, known as the Canadian/USA border. East - the east side of Lake Kooconusa, north up the Kootenay River to where the Wild Horse enters the Kootenay River, then up the Wild Horse to a point north of Fort Steele. West - From the top of White Boar Mountain, down the Goat River to Lavolla Creek up to the height of land, then south along the height of land to the head waters of Englishman Creek, downstream to highway 95 and 3, then down the highway to Kawkins Creek along the creek to the 49th parallel, known as the Canadian/USA border.
Creston Valley Minor Hockey Association	North - from the head waters of Cultus Creek, downstream to Kootenay Lake, up the west side of the lake to La France Creek, upstream to the height of land and across to the top of White Boar Mountain. West - Starting at the 49th parallel at a point south of North Star Mountain, up to the top and across to the top of Summit of the Creston/Salmo following the height of land north to the head waters of Cultus Creek. South - The 49th parallel, known as the Canadian/USA border starting south of North Star Mountain east to the head waters of Hawkins Creek. East - From the top of White Boar Mountain down the Goat River to Lavalia Creek up stream to the height of land, then south along the height of land to the head water of Englishman Creek downstream to highway 3 and 95, then down the highway to Hawkins Creek along the creek to the 49th parallel known as the Canadian/USA border.

Fernie Minor Hockey Association	North - South of the water shed for McCool Creek and Wheeler Creek. South - 49 th parallel known as the Canadian/USA Border. East - The height of land known as the Alberta/BC Border. West - East side of Lake Koocanusa, north up the Bull River to the water shed of McCool Creek.
Fort Nelson Minor Hockey Association	South - Fort St John boundary; West - Rocky Mountains; East - Alberta border; North - Northern boundaries of Wildlife Management Units #7-51, 7-54, 7-49, 7-56.
Fort St. James Minor Hockey Association	From 124 degrees longitude 54 degrees - 20 minutes latitude going East to the Prince George MHA boundary. From 124 degrees - 20 minutes longitude 54 degrees - 10 minutes latitude, then Northwest to McKnab Lake, then further Northwest to the mouth of Sutherland River. Then following the Northshore of Babine Lake to the Houston MHA Northeast boundary. Then Northeast to Fleming Lake, then further Northeast to the South shore of Takla Lake, at the mouth of Tsitsutl Creek. Following the South shore of Takla Lake to the Northwest Arm of Takla Lake at approximately 125 degrees - 1 minute longitude 55 degrees - 18 minutes latitude. Then Southeast to 126 degrees - 33 minutes longitude 55 degrees - 10 minutes latitude. Then Northwest of the head of Babine Lake, then further Northwest to 127 degrees longitude 56 degrees latitude, then due North to the next MHA Boundary.
Fort St. John Minor Hockey Association	South - Taylor boundary, Hudson's Hope boundary and Chetwynd boundary; East - Taylor boundary, Clearview boundary and Alberta border; West - Rocky Mountains; North - Northern boundaries of Wildlife Management Units #7-37, 7-43, 7-44, 7-45, 7-46.
Fraser Lake Minor Hockey Association	North Boundary - from the mouth of the Sutherland River Southeast to McKnab Lake, further Southeast to 124 degrees - 20 minutes longitude 54 degrees - 10 minutes latitude (at Kluk Creek). Then Southwest to Willowdate Road then due South to 53 degrees - 55 minutes latitude, then Southwest to the Burns Lake MHA East Boundary, intersecting 125 degrees longitude at approximately 53 degrees - 40 minutes latitude.
Gold River Minor Hockey Association	The Village of Gold River including Nootka Sound to the west and the communities of Tahsis, Zeballos and Esperanza.
Golden District Minor Hockey Association	North - From the Alberta/BC border, along the Bush River, through the center of the Bush Arm, across the lake to the entrance of the Bachalor River, up the river to where the Gold Creek enters the Bachalor River. West - up to the height of land above Gold Creek and down the other side, along Cupol Creek to where it drains into the Beaver River, upstream to where the Spillimacheen River starts at the height of land. South - Along the Spillimacheen River to the south boundary of the hamlet of Spillimacheen on a straight line to a point north of Kootenay Crossing, up along highway 93 to the Alberta/BC border. Greater Trail Minor Hockey Association	Starting at the American border, north up the Columbia River to the mouth of Beaver Creek, to the west boundary of Montrose and following the height of land on the east side of the Columbia River to Champion Creek, east to the summit of Highway No 3, east to the junction of Highway No. 6 and the Hidden Creek road, up Hidden Creek to the height of and that crosses Highway No. 3 at the summit in Stagleap Park and south to the American border where the American border will serve as the southern boundary. Starting at the American border and north following the height of land east of Christina Lake to the Paulson bridge on Highway No. 3 and north to the boundary between the Kootenay-Boundary and Central Kootenay Regional Districts and east to China Creek, crossing the Columbia River to the height of land on the east side of the river and south along that height of land to the west boundary of Montrose to the mouth of Beaver Creek and following the Columbia River south to the American border with the American border being the southern boundary. Starting at the American border and north following the height of land east of Christina Lake to the Paulson bridge on Highway No. 3 and north to the boundary between the Kootenay-Boundary and Central Kootenay Regional Districts and east to China Creek, crossing the Columbia River to the height of land on the east side of the river and south along that height of land to the west boundary of Montrose to the mouth of Beaver Creek and following the Columbia River south to the American border with the American border being the southern boundary.
Greater Vernon Minor Hockey Association	North - Up to and including Pinaus Lake Road following Highway 97 to Swan Lake junction. East - from Swan Lake go east encompassing Silver Star Mountain and south to Ricardo Road. South - Charolaise Road east to Cedar Grove Road, but not including Cedar Grove. Extending to the center of the lake. Then proceeding southward to a point due east of Caesars Landing. Due south from Ricardo Road to Cruster Creek campground at approx 50 degrees 7" then west to Charolaise Road. West - West to the Thompson- Nicola Regional District Boundary. The western boundary will be moving north along the Thompson-Nicola Regional District boundary to the Pinaus lake Road/Highway 97 junction.

<p>Hudson's Hope Minor Hockey Association</p>	<p>South - District of Hudson's Hope boundary; West - District of Hudson's Hope boundary; East - District of Hudson's Hope boundary and then up the north side of the Peace River to the junction with the Halfway River; North - from the northwest boundary of Hudson's Hope on the north shore of Williston Lake and follow the Dunlevy Creek up to the Graham River and east along the Graham to the Halfway River and down the Halfway to Attachie.</p>
<p>Juan de Fuca Minor Hockey Association</p>	<p>School District #62 from the Parsons Bridge west to Kangaroo Road and the Highland area. Residents of the Township of View Royal shall be in a shared draw zone between Juan de Fuca Minor Hockey Association and Victoria Minor Hockey Association. The residents of this shared draw zone have a onetime choice of where to register starting in the 2005/2006 season, depending on available space. First time registrants shall be with either association. Residents in the district of Metchosin shall be in a shared draw zone between Juan de Fuca Minor Hockey Association and Sooke Minor Hockey Association. Moving westward, following and including the Tranquille Forest boundary to intersect with the Lillooet Land District and the Kamloops Division of the Yale Land District, up to but not including Wentworth Lake. Boundaries extend northeast up to and including Mt Tod. All players residing in Whitecroft Village or Sun Peaks Resorts register with Kamloops MHA. East - Boundaries extend east up to and including Martin Prairie Road including all driveways leading off of Marting Prairie Road. Boundaries also extend south up to but not including Meadow Creek Road. All players living on or south of Meadow Creek Road register with Logan Lake MHA while all players living north of Meadow Creek Road register with Kamloops MHA. West - At the intersection of Tranquille Forest boundaries and the Lillooet Land District and the Kamloops Division of the Yale Land District turn southward following the Tranquille Forest boundary to and including Red Lake. Then move south following the drainage for Copper Creek to its mouth on Kamloops Lake. Cross Kamloops Lake to Six Mile Creek Road.
